PASSES

There will be **4 bracelets included with the vendor fee**. Anyone over and above the 4 will have to pay the regular gate admission. We apologize for any inconvenience this may cause.

SET UP & TEAR DOWN

Outside exhibitors must have display set up by 5 p.m. on Friday September 13th, 2019. Tear down is 5 p.m. on Sunday September 15th, 2019.

Anyone needing **220v power** needs to be in and set up by 1pm on the Friday so they can get hooked up by a certified electrician, as we don't have sufficient plug space, and some may need to be wired directly into the panel. If you are not in by 1pm we cannot guarantee that you will have hydro hook up or the space reserved for you.
